General

This list comprises miscellaneous works, across the disciplines, that either focus on or relate in part to the Upper Zambezi Valley region and/or its peoples, known variously as Barotseland; Western Province, Zambia; Western Zambia, North-Western Zambia; North-Western Rhodesia; Lozi/Malosi/Barotse/Marotse/Murutse; Luyi; Mbunda; Balovale; Luvale; Nkoya; Caprivi; Few/Mafwe; Subia/Subiya/Basubiya/Masubiya; Mbukushu/Hambukushu; Ila/BaIla/Mashukulumbwe/Bashukulumbwe.
